# **Keith and East Locality Project**

Newsletter 6 – October 2022

### What is the current position?

There is currently **no funding identified** for the Keith Health centre facility.

The current commitment from NHS Grampian is to support the completion of the Initial Agreement stage of the business case **only.** Once the Initial Agreement document has been completed, **t**his will then be considered by NHS Grampian's Asset Management Group as part of the health board's longer-term planning and prioritisation of capital projects for Grampian region.

#### What stage is the project at?

We are following the Scottish Government's business cases process for health and care developments. There are, a number of stages that must be progressed.

The first stage is the Initial Agreement, which is followed by an Outline Business Case and a Full Business Case.

Each stage requires endorsement from HSC Moray and NHS Grampian, before submitting to the Scottish Government for approval. This journey fundamentally takes a few years to complete. However all this is very dependent on funding being made available.

The first steps of a long journey is already underway. We are focusing on delivering the Initial Assessment stage of the Business Case for a Health and Care Hub. This will principally focus on primary care, community-based and ambulatory services that are currently available locally and what is required for the future.

## What is to happen next?

The purpose and objectives of the project is to:

- Identify the ambulatory care services that patients access in the Keith Locality and the wider Moray area;
- Reflect on and assimilate pertinent findings from a Speyside review, that takes account of the needs of the Keith and Speyside population in terms of health and social care;
- Consider the wider context within which any planning should take place and seek to bring together the broader vision for the health and social care system locally;
- Reflect on learning from the changes made to service delivery during the Covid 19 pandemic and include any/all insights in the planning phases;
- Identify the optimal model of care, by ensuring that it:
  - will deal with future surge and demand on services;
  - will provide better outcomes for patients and the needs of our vulnerable populations, and
  - services will be delivered in, or close to, patients' homes

To assist with the identification and scoping of the ambulatory care services that patient's access in the Keith Locality and the wider Moray area, we have held four workshops. Stakeholders from Keith patient participation group, TSI, Quarrier's, Scottish Ambulance, The Moray Council, Keith Health centre as well as a range of

staff from Community Services, Health & Social Care Moray and NHS Grampian attended the following workshops.

We will keep you informed as each of these workshops progresses so that you are aware of how the business case is being developed.
